Petitioner shall file its 2020 Annual Report with the Department unless it files 11 Articles of Dissolution with the ACC on or before December 31, 2020 12 5. Petitioner shall pay its Certificate of Authority renewal fee to the Department 13 unless it files Articles of Dissolution with the ACC on or before March 31, 2021. 14 6.
